The meeting was called to order at 6:30 pm by Supervisor Donald Foster.

Pledge of Allegiance

Privilege of the Floor

1. Rich Nichols, residing at 420 Acres Avenue, Waverly followed up with the board regarding his high water bill. He stated at the previous meeting it was discussed that a flow test be completed on the old water meter, however it was torn apart and unable to be tested. Supervisor Foster advised that the Town of Barton policy states that if the water goes down the drain to the Waverly Treatment Plant that relief is not granted on the sewer portion.

Supervisor Foster stated that everything was looked over by the Village and there were not any confirmed leaks and that the Town of Barton bases the decision on what the Waverly Water Department and the Water and Sewer Clerk says.

Councilperson Everly advised Mr. Nichols to approach the Waverly Water Commission. Supervisor Foster stated that IF the Village would grant Mr. Nichols relief, then the Town of Barton will grant relief on the sewer portion.

Approval of Minutes: Councilperson Jeff Coleman recommended the minutes of the previous meeting be put on hold pending an edit by Town Clerk Richards-McCarty.

- 2. In accordance with General Municipal Law §300, all municipalities with a population over 1,500 are required to maintain an official website using a ".gov" domain name. I have placed a copy of the statute in each of your folders for reference. This requirement must be implemented by December 21, 2025. Arrah will begin exploring the process of converting our current website to a ".gov" domain upon her return.

Highway Superintendent Fred Schweiger

- 1. On the ".gov" topic, Donnie, Arrah and I met with IT regarding their new pricing structure. It's not as bad price wise, we will be actually saving about \$2,000. Recommend that we stay with the county IT program. It is safer and they do back up computers regularly and there's a second set of servers up on Carmichael Road.
- 2. During the Association of Towns advocacy meeting in March, it was mentioned that they are pushing for a CHIPS-like funding structure for sewer and water programs. It hasn't been approved yet with the state budget, however, it might be something we

get additional funding now and then to help with sewer pumps.

- 3. The highway department switched to 10-hour days. We are 6:00am-4:30pm Monday through Thursday. The first holiday will be taken on April 21st.
- 4. Road sweeping has been being done as weather permits. We need the rain to keep the dust down, otherwise it becomes unsafe for whoever's operating it.
- 5. Stanley Blacktop plant opened today, so the crew was out patching today trying to get ahead of what we will be oiling and stoning and having hot pavement roads done. The hot pavement projects will be the completion of Old Barton Road and Cannonhole Road and Ridge road from the four corners of the Talmadge Hill areas. It looks like we can go to about Oxbow road with our budget. Oil and stone treatments: double coats on West Pine, Walker, Valley View, Reeves, Golden and Ellison. Williams, Bonham, Cumber and the north end of Prospect from Tinkham to Ellis Creek will be stone course with the sand seal is what they're trying out now, which cuts the price down and saves some money.
- 6. No word on any increase in CHIPS funding.
- 7. Mr. Schweiger presented to the board 3 (three) quotes along with a proposal for building a Salt Shed to provide the Highway Department with more storage, thus offsetting any future supply issues. With the current Salt Shed, the highway department relies on weekly supply drops which isn't a lot of product on hand because it is a small building. Being able to inventory at least half of the procured quota per year will help smooth out any future supply problems. Retaining wall blocks, an asphalt binder floor and a container canopy system would be used for the roof. The walls will be about 10 foot tall with the total dimensions of 42' x 100'. With the Highway Department performing the work, it will eliminate the engineering cost. Mr. Schweiger explained the process, warranties and prices for each of the three quotes provided. Mr. Schweiger recommended using Britespan for the proposed Salt Shed. They are Sourcewell approved contracts, have New York State dealers and come with a 25-year warranty. The Britspan shed would have a 28' dumping center. With the bigger Salt Shed we will still keep the smaller shed for sand/salt mix in the existing shed and it will eliminate leaching and wasted product.

Motion to reserve and hold the Salt Shed made by Councilperson Kevin Everly, seconded by Councilperson Dave Shipman. All in favor.

WHEREAS, due to increasing state regulations, Stray Haven Humane Society will no longer accept dogs from the Town of Barton; and

WHEREAS, the Barton Town Board deems it essential to have a shelter for the housing of stray dogs; and

WHEREAS, Karen Garrity/Furry Friend Inn has a proposal for the accommodations and shelter of stray dogs for the Town of Barton Town Board's consideration; and

NOW THEREFORE upon a motion by Councilperson Kevin Everly, seconded by Councilperson Dave Shipman, and carried; therefore, be it

RESOLVED, that on this day, April 14, 2025, the Town Board of the Town of Barton, County of Tioga, State of New York, hereby approves the agreement between Karen Garrity/ Furry Friend Inn and the Town of Barton as set forth as follows:

PROPOSAL:

For accommodating stray dogs brought in from the Dog Warden covering Tioga County.

A charge of \$1,200.00 (this is to be used towards any vet bills required for any dog brought into the facility. Including vaccines needed to make such dogs are adoptable after their initial 5-day hold.) This fee does not include any spay/neuter.

This fee will cover a one-year period. If unused at the end of the one-year term all monies remaining will be reimburse to the Town of Barton. This fee would be collected at the time of a signed contract between Furry Friend Inn and the Town of Barton.

A fee of \$35 a night will be charged to accommodate a (single) stray dog up to and including a five-night stay. If the dog is picked up on the 5th day/night after 12 pm there will be a charge of a full \$35 for that night.

Included in that \$35 fee. Said dog will be treated with kindness, housed in a clean, temperaturecontrolled room with fresh water, fresh food, and clean bedding. The dogs' room will be cleaned daily and fresh water and food will be given in the am/pm. He/she will also have ample outside playtime and fresh air. And if possible, socialization with other dogs.

Furry Friend Inn will do everything possible to help locate the pet parents of said strays. We will post pictures and information on Face Book to help locate the families.

After the five-day hold and a dog has not been placed back with his/her family Furry Friend Inn has the right to find adoptive parents for such a dog. With the option to charge a fee (to the adoptive family) to cover the extended stay at Furry Friend Inn.

In the unpleasant circumstance that a housed stray was to bite or harm an employee of Furry Friend Inn and such employee needed medical attention, the Town of Barton would be responsible for any medical bills incurred by the employee.

Furry Friend Inn does have the right to refuse any stray that appears to be aggressive towards humans. Any stray that may appear sick or diseased, or needs immediate medical attention.

Furry Friend Inn will keep in communication with the Dog Warden/Town of Barton during the five-day holding period of said dog. Keeping them up to date on all progress being made on locating the dog's family.

Throughout the term of this contract between the Town of Barton and Furry Friend Inn both parties agree to work together for the good of the canines, including housing and health.

All emergencies will be a discussion between both parties as to what avenue is to be taken (when possible).

If a dog (stray) was to pass away during his/her five-day holding period it will be the Town of Bartons responsibility to come and remove the deceased animal from the premises of Furry Friend Inn.

And be it.

FURTHER RESOLVED, that the Town Board of the Town of Barton grants the Town supervisor authority to sign any documentation necessary to carry out implementation of this resolution; and be it

FURTHER RESOLVED, that this resolution shall take effect immediately.
