RESOLUTION NO 35-2024

SEWER BILL ADJUSTMENT DUE TO LEAK-  
ELENA CELLA

**WHEREAS**, Town of Barton water/sewer owner, Elena Cella, requested sewer forgiveness for the property located at 311 Norris Road., Waverly, New York due to a leak; and

**WHEREAS**, Village of Waverly Water Department confirmed this leak did not go into the sewer pipes; and

**WHEREAS**, the Town of Barton Town Board requests that the Water and Sewer Clerk take the average of the last four water and sewer consumptions prior to the leak and charge only that average to the landowner; and

**NOW THEREFORE** upon a motion by Councilperson \_\_\_\_\_, seconded by Councilperson \_\_\_\_\_ and carried; be it

**RESOLVED**, the Town of Barton Town Board, Tioga County, New York approves the owner's request to adjust the sewer portion only of the recent water and sewer bill due to a leak beyond their control; and be it

**FURTHER RESOLVED**, the water and sewer bill be reduced from \$1,700.34 to \$798.25, with an adjustment to the sewer portion only, totaling \$902.09; and be it

**FURTHER RESOLVED**, this resolution be forwarded to the Village of Waverly.

APPROVE CONVEYANCE OF FORMER BARTION FIRE  
SUB STATION PROPERTY TO THE TOWN OF BARTON

**WHEREAS**, At a meeting on June 17, 2024, the Waverly-Barton Fire District Board of Fire Commissioners deemed it fitting to return the Barton Fire Sub Station property to the Town of Barton, provided the town has an interest and use for the property and would like the property back; and

**WHEREAS**, The Town Board of the Town of Barton is in favor is reacquiring this property; and

**NOW THEREFORE** upon a motion by Councilperson \_\_\_\_\_, seconded by Councilperson \_\_\_\_\_ and carried; be it

**RESOLVED**, that on this day, September 9, 2024 the Town Board of the Town of Barton, County of Tioga, State of New York hereby approve the conveyance of the former Barton Fire Sub Station property to the Town of Barton for the consideration of one and 00/100 (\$1.00) lawful money of the United States; and be it

**FURTHER RESOLVED**, that the Barton Town Board grants the Town Supervisor the authority to sign any and all documentation needed to fulfill implementation of this resolution.
